MOTION FOR AN EXTENSION TO SERVE AND FILE

Counsel for David Glover respectfully requests a **final thirty (30) day extension, from June 15, 2022 until July 15, 2022**, in which to serve and file the Petition for Writ of Certiorari and Appendix in this case. This motion is made pursuant to the Order of the South Carolina Supreme Court dated March 18, 2009. This is a third request for an extension. In support of this request, counsel shows:

1. The Petition for Writ of Certiorari and Appendix are due to be served and filed with the Court today.



Rickey Tate with the Court of Appeals on June 9, 2022. Counsel filed the Anders brief of appellant and designation of matter in the case of The State v. Brandal Smith with the Court of Appeals on May 25, 2022. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of William A. Seawright v. The State with this Court on May 9, 2022. Counsel filed the initial brief of appellant and designation of matter in the case of The State v. Michael Means with the Court of Appeals on April 20, 2022. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Raphael L. Pontoo v. The State with this Court on April 11, 2022.

4. Counsel makes this request in good faith and not for purpose of delay.


