Dear Ms. Allen:

We received your May 19 letter inquiring about the status of the transcripts in this matter. We submitted our transcript requests to the Office of Court Administration on March 17, 2022, and received an email acknowledging receipt of the requests. We also notified the Court of our transcript requests by letter on the same day.

Pursuant to Rule 207(a)(2) of the South Carolina Appellate Court Rules, the transcripts are to be delivered within 60 days after the date of the request. Rule 207(a)(5) provides that we must notify the clerk, Court Administration, and the court reporter if we have not received the transcripts within 60 days nor received notice of an extension within an additional 10 days after expiration of the 60-day period. The 60-day period ended on May 16, 2022, and the additional 10-day period expired on May 26, 2022. As of the date of this letter, we have not received the transcripts nor a formal notice of extension.

According to the enclosed May 19 email and May 20 letter from the court reporter, she first received our March 17 transcript requests from Court Administration on May 17, 2022. Our understanding is that the court reporter is in the process of producing the transcripts. We will promptly notify the Court upon receiving any further status updates.
