Response to Response Motion to Reverse

The Respondents stated I have demonstrated a pattern of failing to follow orders.

This statement is inaccurate as there is only evidence on each order given by the court I have completed each one including the deficiencies.

I ask the court to consider I am not a lawyer, have a job and caretaker for my parents so there have been request for extensions and minor errors in the 750 page

Record of Appeal. Also, not to mention one record of Appeal was lost by the court thus had to resend.

The last Record of Appeal on file has not been rejected by the court with any Deficiencies. I have filed 750 pages of the Record of Appeal 5 times, I check the Record Of Appeal for errors, pages, exhibits in order and missing pages and have fulfilled the requirements.

Respondent states there is no effort or lack of follow up as such not concerned with the court Proceedings. I have filed over 10,000 documents at my own expense attempting to execute my right at a US citizen to be heard from a jury of my peers as requested in the lower court. I communicate directly with court by phone to clarify what is needed and follow up accordingly

The only pattern is by the Respondent, in the lower court just weeks before jury trial he Files A motion for Partial Summary Judgement that somehow allows a local judge to be the Jury and make a ruling without a jury of my peers.

Now, weeks before being heard in the Appellant Court, files a request to dismiss and as such awarded.

In both cases a South Carolina Court dismissed my right to be heard by a jury of my peers. Perhaps as I appeal each ruling I will find an impartial person that does not live in the State of South Carolina and will finally reverse a decision and allow me to be heard by a jury of my peers.

It was as simple ask in the lower court, let an American Citizens be heard by a Jury of twelve hear not a singular local judge.

The Respondent and lower court has denied me that right including defaming my name with associated damages.

I have followed the courts orders never missing any dates including all filings.

Perhaps a 750 page Record of Appeal was not a good strategy as it appears in each Record there were a few pages numbers wrong and mis-aligned Exhibits. I ask the Court to provide understanding of my efforts and current accurate Record of Appeal on file thus reversing the decision to dismiss

The question is why is so hard in South Carolina that 4 years later my simple request to be heard by a jury of my peers, a right as a US Citizen, not be granted. Lawyer vs Citizen, I understand rules need to be followed but using time and lack of effort to dismiss appeal make no sense because I have fulfilled all court orders. At no time has the court ever noted a maximum number of deficiencies, maximum time limit including maximum number of Record of Appeals filed.
