Greetings and salutations to you and each of you this presents,

I think there's a misunderstanding according to your response, because it appears the appeal and/or Challenge, I sent was altered without my consent or knowledge. For example, the challenge and/or appeal was against CLARKSON & HALE LAW FIRM, LLC – DBA- MIDLAND CREDIT MANAGEMENT, LLC; Moreover, upon reviewing your document you change the appeal to **Midland Credit vs Robert .T Weston with case number 2022-000742**; In addition you claim my appeal and/or challenge is not in compliance with the SCACR;

Title 18 § 2071 a) Whoever willfully and unlawfully conceals, removes, mutilates, obliterates, or destroys, or attempts to do so, or, with intent to do so takes and carries away any record, proceeding, map, book, paper, document, or other thing, filed or deposited with any clerk or officer of any court of the United States, or in any public office, or with any judicial or public officer of the United States, shall be fined under this title or imprisoned not more than three years, or both;

(b) Whoever, having the custody of any such record, proceeding, map, book, document, paper, or other thing, willfully and unlawfully conceals, removes, mutilates, obliterates, falsifies, or destroys the same, shall be fined under this title or imprisoned not more than three years, or both; and shall forfeit his office and be disqualified from holding any office under the United States. As used in this subsection, the term "office" does not include the office held by any person as a retired officer of the Armed Forces of the United States.

Please understand I'm not arguing and/or blaming you at all I'm just stating my concerns; Therefore, I hope we can start this process over again due to the incorrect filling as well as reiterate what my initial challenge is with CLARKSON & HALE LAW FIRM, LLC-DBA-MIDLAND CREDIT MANAGEMENT, LLC; 1 they never rebutted any of my points presented to them prior to the judgment after several documents have been sent and

filed in the public record without a response, which is their acquiescence, a tacit agreement of conduct; Moreover, since all courts operate in commerce a notice and/or affidavit unrebutted becomes judgment in commerce or commercial law;

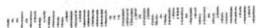
