knows that people are out to kill me. These staff members Force a
mother inmate in the same suicide watch with me both of us was
on 5:30 watch in the same cell together and they beat both of us in
the same suicide watch cell over night. The inmate names James Davis
Staff members names are S.I. Thompson, Cpl. Smith, Cpl. Robinson, Mr. Kerner,
Mr. Brown and Miss Lively. They was direct by Lt. Brigant Major G.E. Allen -
Director Philip Foot. When they put both of us in the same suicide
watch cell together on suicide watch I ended up with Sexual Abuse -
Abuse ON: 2-4-2014 G.V. Suicide watch here at B.C.D.C. I'm scared
fear for my life here at B.C.D.C. All my rights have been violated.
Every time I think about this a B.C.D.C. and staff heads violated and
my voice, I can't sleep, eat, function or think still. I'm scared fear
for my life here at B.C.D.C. ON: 2-4-2014 I was Sexual Abuse - Rape
by another inmate we both was on suicide watch in the same
cell together. I'm scared for my life here at B.C.D.C. 10/6/11
