At a Court of General Sessions, convened on December 9, 2021, the Grand Jurors of Colleton County present upon their oath:

Criminal Sexual Conduct With a Minor, Third Degree

That in Colleton County, South Carolina, on or about October 1, 2016 through October 10, 2016, the Defendant, Ricky Devon Edwards, Jr., did, while over fourteen years of age at the time of the offense, wilfully and lewdly commit or attempt to commit a lewd or lascivious act upon or with the body, or its parts, of Kirstian Donofrio, who was under sixteen years of age at the time of the offense, with the intent of arousing, appealing to, or gratifying the lust, passions, or sexual desires of Ricky Devon Edwards, Jr. or Kirstian Donofrio; all in violation of Section 16-3-855(C), et al. of the Codes of Law of South Carolina.
