PROOF OF SERVICE (reiterated per the Clerk of the Court of Appeals' Request)

In compliance with the Clerk of the Court of Appeals' deficiency letter dated 7 July 2022 but not uploaded on C-Track to be visible to the public until 8 July 2022, I reiterate that, based on my personal knowledge and clear recollection OR information and belief, I had served the Notice of Appeal signed by me and hand-delivered to the Supreme Court of South Carolina on 15 March 2022 through Mr. Dan Addison's having electronically served a copy on Mr. Marshall James, and another copy on Ms. McBride, Clerk of Richland County's Clerk of Court. **Mr. Addison, my forced counsel for the underlying case at the time, took the strange position that he had no duty to file over his own signature a notice of appeal on my behalf but had the exclusive right to serve any notice of appeal over my own signature and that both SC Circuit Judge Brown and the Clerk of this Court had told Mr. Addison to proceed that way.** I have no way of knowing if Mr. Addison was telling the truth as I was, and still am, under penalty of incarceration for contempt of court, prohibited from contacting Judge Brown or the Clerk of this Court. **But I could see on the Public Index that the Notice of Appeal was timely served electronically by Mr. Addison on both Mr. Marshall and Ms. McBride.** I cannot change the past and am tired of all those naked efforts to entrap me into contempt of court; but I will never tell lies.

In response to the 13 June 2022 deficiency letter, I suffered a hit-and-run on 18 June 2022 and had to report to incarceration on 27 June 2022, where and when I suffered atrial fibrillation which still affects me, but I had served the motion to appoint counsel on both Mr. Dudek and Mr. James by hand-delivery to their respective offices. I even filed a copy stamped "Received" that day by SC's Commission on indigent defense.
