Also, any payment made may be reportable to the National Practitioner Data Bank and the Medical Licensing Board(s) in the state(s) where I hold an active or inactive license, as required by law. Dr. Miller,

Thank you for speaking with me and Ashby yesterday about this case. As we discussed, this matter has been presented to our internal trial committee, and all were in agreement to take this matter to trial as we feel it is a defensible case. In addition, we have the new Statute on our side, and again, even if you were to be found negligent by the jury, you would still receive a defense verdict. He will have to work hard to prove gross negligence in this case. Mr. Graham, is a good attorney, however, the jury will start to see through him, and that won't go well for him.

As indicated yesterday, this is not a case in which MagMutual is going to settle prior to trial. I spoke to Sam McEwen this morning about the trial since I cannot attend. He said that he would try to attend a few days of the trial. I have attached the Consent to Settle Form for you to sign and return to me via email. Ashby will be analyzing the trial daily, and will report to me each evening. I will share this information with my Team Lead, and VP of Claims, and we will evaluate the case daily to determine next best steps.

Between you, and our very strong stable of experts, you all will be able to educate the jury on the medicine. Again, you were the one there, you know how much force you used, or didn't use. I would like to remind you to try very hard not to let Mr. Graham get under your skin. You need to be the nicest, most respectful witness at this trial. Let him tarnish his character in front of the jury, while you remain calm, confident, but not cocky.

Thanks so very much. I wish you and your family a very Merry Christmas, and may the new year put this all behind you.
