They had nothing that's why they didn't bring a warrant. They told me if I would go along with their story they wouldn't ask for any more time but the sentence I was already doing and they never even tried to help me. I helped them and they helped my codefendant. We this crime happened I had been not taking my mental meds properly and drinking all night. So what I remember is the morning of this crime Grady was going to take me home. I guess he took me to help him with the crime. I woke up the next morning and had nothing different on me or in my house that wasn't mine. I even lost the hundred a 34 dollars I had on me. I guess Grady robbed me
