My apologies - I corrected the court date to reflect 2022 instead of 2020. Thank you for catching that. Let me know if you need anything else.

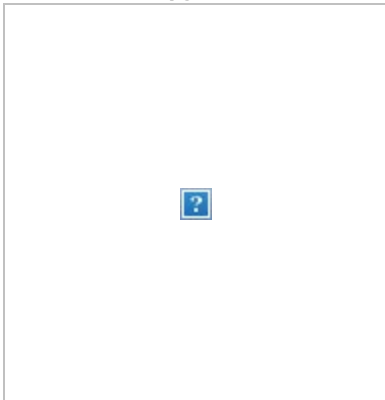


