

At a Court of General Sessions, convened on NOVEMBER 23, 2021 the Grand Jurors of FLORENCE County present upon their oath:

**COUNT ONE – ARMED ROBBERY**

CDR: 0139 16-11-0330(A)

That Satwaun Wallace Henryhand did in Florence County on or about November 22, 2019, while armed with a deadly weapon, to wit: a handgun, or while alleging, either by action or words, that he/she was armed while using a representative of a deadly weapon or any object which a person present during the commission of the robbery reasonably believed to be a deadly weapon, take and carry away personal property of Suburan Extended Stay Hotels from or in the immediate presence of Suburan Extended Stay Hotels with intent to deprive Suburan Extended Stay Hotels of possession by use of force, threats or intimidation, in violation of Section 16-11-0330(A), S. C. Code of Laws, 1976, as amended.
