Appellant is attempting to file a Notice of Appeal in the Court of Appeals for (2) disciplinary convictions that arose from D.H.D. proceedings in S.C.D.C. On March 22, 2013 ALJ Deborah Brooks Darden dismissed the (2) convictions cases 12-ALJ-04-0546-AP and 12-ALJ-04-0547.

Appellant has a right to appeal this action to the Court of Appeals, But he must abide by court rules in filing his Notice of Appeal by filing the Notice of Appeal, Proof of Service, Informa Pauperis, and a copy of the ALC's Order. The General Counsel Christopher Florian, The librarian at Tyger River C.I. Mrs. McCabe, and Mail Room Supervisor MR. Crider are preventing him from doing this.

On April 3, 2013 Mrs. McCabe told Appellant his case had been dismissed and he cannot appeal it. Then she refused to make copies of Judge Darden's order so he could serve copies on the Court of Appeals, ALC, and General Counsel. She stated "she is following instructions of General Counsel Christopher Florian." Appellant was denied again on April 4, 2013 by stating "I still cannot copy the requested documents."
