Due to the fact I was prevented from complying with the Appellate Court order dated June 17, 2022, I withdraw my Appeal!

However I have been incarcerated since a falsified warrant: warrant # 2021A3210201743, sex/sex offender Registration violation, fail to Reg. 3rd or Sub. offense! The warrant was falsified and was falsified to cover up illegal actions of the Lexington and Newberry Sheriff's office!

I was in Newry in violation of South Carolina sex offense laws, further the warrant was enhanced, I have never been convicted of a 1st or 2nd offense! The warrant also states I was not registered with no agency as of May 18, 2021! The warrant date is June (6/15/2021) 16, 2021! However I was living where I registered at, with the Lexington County Sheriff on April 08, 2021, with 24 Twenty four hours of Bonding of the Newberry Co. Detention Center on a February 2nd 2021 failure to Reg 1st and February 5th 2021, failure to Reg 3rd! The warrant states I was suppose to re-register on one (1) of (1) first

May 15, 2021, However on ~~April~~ April 08, 2021 I registered and The Detective that conducted and completed the Registration, And posted my picture online, Provided me with Verbal Instructions as well as printed instructions to reregister By August 01, 2021! Also the Lexington County S.O.P. Office Has Audio and video Surveillance Also!

The Lexington County Public Defender Robert Heath Owen (Office of Disciplinary Conduct file Number 22-DE-L-0264, which was Removed April 17, 2022, after nine months of pro se filed complaints) Has made a Mockery of the justice system! The first time I appeared in court since Incarceration on July 05, 2021, the only Testimony Owen gave was 'Mr Scott was found Incompetent on November 04, 2021, And the Dept of Mental Health Requested that I place Mr. Scott in there facility for a (60) sixty Day Evaluation! The same Testimony was given by Owen ~~himself~~ on April 17, 2021! Owen Also stated that the Reason He filed a Motion to have me Evaluated was Because of my Incoherence and inability to formulate speech Properly! →

However Owen filed the Evaluation Request
After I filed a Complaint with the
South Carolina Bar for ineffective Assistance
of Counsel And for Not Removing himself
with Conflicts of Interest; Also in September
2021, Pamela Ethridge of the Lexington
County Public Defender Office, stated on a
phone conversation that she thought the
Solicitor was Dismissing my case. The
continuous lack of prosecution in my
case is undictive as are the actions
of Owen and 11th Judicial Assistance Solicitor
have Hadly Wain II; However the Lexington
County Public Defender Appointed to Represent
the Debra Dean, PA, however during a
brief fifteen minute interview at the end
of April, Dean stated she was not going
to take any action in my case until
after the SC Dept of Mental Health
Forensic unit conducts the requested 60
day Evaluation; However Rejected Request
to the Lexington County Court of
General Sessions. Have been ignored as
of today July 07, 2021. I am being
held inhumanly on a falsified Warrant,
and there is no legal reason for
Three (3) or four

The S.C. Dept of Mental Health to be
Requesting a Inpatient Evaluation, I was
Evaluated ~~April 08, 2021~~ November 04, 2021
for Competency, At which time Owen, Did
in fact mislead the Evaluation, and
Contradicted my every word! I have been
held for 366 days on a falsified warrant,
The S.C. S.O.R.N.A website clearly showed
I was registered with Lexington Co, Sheriff
office as of April 08, 2021! Prosecuting officer
Charles R. Chandler-501102, was involved in the
July 2020 Incident, & filed complaint with
Alan Wilson office civil rights division. The case
I am incarcerated on is a mockery of
The justice system, vindictive prosecution
and corporal punishment!

I withdrawn my Appeal for various
reasons! However upon the eventual conviction
In the case of a July Trial, I will
refile the appeal!


