not provide for successive petitions for supersedeas. Therefore, Appellant’s


third petition for supersedeas is denied, and this court will not act on any further petitions for supersedeas in this underlying case.

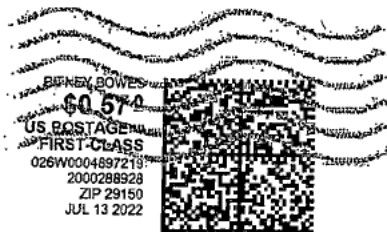
