
INDICTMENT FOR

That JOSEPH MARTIN SWARINGEN did in Greenville County, on or about the 18th day of November 2020, knowingly sell, manufacture, deliver or bring into the State of South Carolina or did knowingly provide financial assistance or otherwise aid, abet, attempt or conspire to sell, manufacture, deliver or bring into the State or was knowingly in actual or constructive possession of more than 28 grams, but less than 100 grams, of Methamphetamine (Crank) This is in violation of §44-53-375 of the South Carolina Code of Laws (1976) as amended.
