Please permit this correspondence to serve a notice there is a lack of information relating to the purported filing of a JOHNSON Brief under the above referenced docket number.

On June 29, 2022, this Office serve me with notice of a forty-five (45) day period for the filing of a pro se JOHNSON Brief, form the date of this service. This correspondenmce was served upon me, via Institutional Legal Mail Services on July 5, 2022. I am further placed on notice that, if, I failed to respond within forty-five (45) days, the Court will have submitted acopy of the JOHNSON Brief, and the Court will consider it's merits.
