




INDICTMENT FOR

Trafficking Methamphetamine  
§44-53-375(C)

At a Court of General Sessions, convened on the 8th day of April, 2022, the Grand Jurors of Laurens County present upon their oath:

The defendant, Wendy Michelle Green, did on or about June 4, 2020, in Laurens County, South Carolina, knowingly sell, manufacture, deliver, purchase, or bring into this State, or did provide financial assistance or otherwise aid, abet, attempt, or conspire to sell, manufacture, deliver, purchase, or bring into this State, or was knowingly in actual or constructive possession or knowingly attempted to become in actual or constructive possession of ten grams or more of methamphetamine as defined and otherwise limited in Sections 44-53-110, 44-53-210(d)(1), or 44-53-210(d)(2), all in violation of Section 44-53-375(C), Code of Laws of South Carolina (1976, as amended).

**Against the peace and dignity of the State, and contrary to the statute in such cases made and provided.**
