MOTION FOR AN EXTENSION OF TIME

Counsel for John Willie Mack respectfully requests an extension of thirty (30) days until August 26, 2022 in which to serve and file the Petition for Writ of Certiorari and Appendix in this case. This motion is made pursuant to the Order of the South Carolina Supreme Court dated March 18, 2009. This is a second request for an extension. In support of this request, counsel shows:

1. The Petition for Writ of Certiorari and Appendix are due to be served and filed with the Court today.
2. Counsel for John Willie Mack respectfully submits that extraordinary

circumstances exist which warrant the granting of an additional extension of time. Given the number of extensions previously granted and the order in which counsel attempts to manage her caseload, counsel hopes that no further extension requests will be required.

The State with the Supreme Court on June 29, 2022. Counsel filed the Petition for Writ of Certiorari and Appendix in the case of Holly Jo Thompson v. The State with the South Carolina Supreme Court on June 13, 2022. Counsel filed the Petition for Writ of Certiorari and Appendix in the case of Worth Edward Cook, III v. The State with this Court on June 7, 2022.

4. Counsel makes this request in good faith and not for purpose of delay.


