LASTLY, I DO NOT KNOW WHO WILLIAM BLITCH IS SO I AM NOT ABLE TO COPY HIM ON THIS REPLY. ADDITIONALLY, SINCE BENJAMIN MACK STATED ON THE AFTERNOON OF 13 JULY 2022 THAT "BECAUSE NICK URICCHIO F---ED UP", PERHAPS THE CHARLESTON COUNTY PUBLIC DEFENDER CORPORATION SHOULD/WILL ASSIST IN THIS APPEAL. FOR CONTEXT PURPOSES, MR. MACK'S RESPONSE ABOVE WAS MADE IN RESPONSE TO MY INQUIRY ABOUT WHY MR. URICCHIO REQUESTED A BENCH WARRANT ON 3 JUNE 2022 INSTEAD OF JUST REQUESTING JUDGE HOCKER SIGN AN ORDER REQUIRING ME TO ATTEND A CONTENT HEARING; WHAT

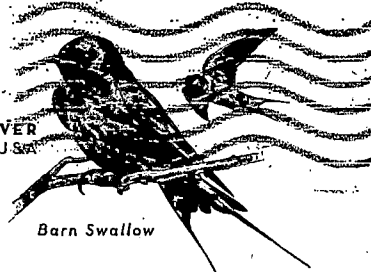
