BEING ARRESTED ON HIGHLY QUESTIONABLE BENCH WARRANTS

DEAR JUDGE JEFFERSON,

I AM WRITING TO YOU TO ATTEMPT TO ADDRESS WHAT I UNDERSTAND ARE YOUR CONCERNS ABOUT FULFILLING YOUR RESPONSIBILITIES AS CHIEF JUDGE FOR ADMINISTRATIVE PURPOSES RELATIVE TO ME AND THE STATE OF SOUTH CAROLINA AND AT LEAST ONE OF ITS POLITICAL SUBDIVISIONS (EG. NIX CHSSC)

ON THE AFTERNOON OF 5 JULY 2022, WHILE BEING INCARCERATED AT THE CHARLESTON COUNTY DETENTION CENTER, BENTAMEN MACK RELAYED TO ME THAT I WOULD HAVE TO SPEND EXTRA TIME INCARCERATED ON THESE TWO BENCH WARRANTS BECAUSE YOU DID NOT WANT TO PERFORM YOUR DUTIES AS CJAP WHERE NIX CHSSC ARE INVOLVED. MR. MACK WENT ON TO STATE THAT THE REASON YOU HAD PROVIDED WAS THAT I HAD SUED YOU.

IT IS INDISPUTABLE THAT I HAVE NEVER FILED A LAWSUIT OF ANY NATURE AGAINST YOU. I HAVE ALSO NEVER CONTEMPLATED SUCH PREVIOUSLY.

MR. MACK ALSO STATED ON THE AFTERNOON OF 5 JULY 2022 THAT "IF YOU KEEP PISSIN' EVERYONE OFF, THEY ARE GOING TO THROW YOU IN PRISON FOR FIVE (5) YEARS". THE "YOU" IN THAT QUOTE REFERRED TO ME, ALAN NIX.

MY INTERPRETATION OF THE WORDS "EVERYONE" + "THEY" IN THE QUOTE WAS TO REPRESENT A GROUP OF PERSONS THAT I HAVE SOMEHOW DONE SOMETHING TO "PISS" OFF AND MR. MACK WAS SUFFICIENTLY AWARE OF WHO "THEY" ARE AND THEIR ABILITY TO ACTUALLY CARRY OUT THEIR THREAT TO "THROW YOU (ME) IN PRISON FOR (5) YEARS.

BASED ON MY LIMITED EXPOSURE TO YOU AS A JUDGE IN AUGUST 2019, I HAVE SUBSTANTIAL DOUBTS YOU ARE PART OF "EVERYONE" AND "THEY" MR. MACK REFERENCED IN HIS QUOTE ABOVE. PART OF THE REASON FOR MY DOUBTS ABOUT YOUR WILLINGNESS TO ENGAGE IN SUCH CONDUCT IS DUE TO YOUR CANDIDNESS TO ACKNOWLEDGE DURING THE HEARING OF AUGUST 2019 THAT THERE ARE JUDGES THAT YOU HAVE QUESTIONS ABOUT RELATIVE TO THEIR COMMITMENT TO JUDICIAL/ ATTORNEY ETHICS AS WELL AS YOUR CORRECT LEGAL POSITION IN DENYING MR. COUNTRYMAN'S REQUEST FOR A SELF SERVING SANCTIONS.

BASED ON THE ABOVE, I REQUEST THAT YOU REEVALUATE YOUR CURRENT POSITION RELATED TO YOUR ASSIGNMENT AS CJAP AND NIX CUS SC OR ASSIGN THESE DUTIES TO ANOTHER UNCONFLICTED JUDGE WHO CAN EXPEDITIOUSLY RULE ON SUCH MATTERS LIKE THE VALIDITY OF THESE BENCH WARRANTS WHICH HAVE NOW KEPT ME INAPPROPRIATELY INCARCERATED FOR GOING ON 26 DAYS.

FOR A BRIEF RECAP OF THE DAMAGES / POTENTIAL DAMAGES THIS CLEARLY INAPPROPRIATE INCARCERATION HAS CAUSED MY FAMILY AND I, I HAD TO SPEND MONEY AND TIME REQUESTING AN EXTENSION OF TIME TO COMPLETE A HIGHLY RELATED WRIT OF HABEAS CORPUS WITH THE SOUTH CAROLINA SUPREME COURT, I HAVE A CRITICAL MONTH IN RETAINING COUNSEL TO PURSUE DAMAGES AGAINST THE PARTIES INVOLVED IN THE ILLEGAL SALE OF MY FAMILIES HOME AND SUBSEQUENT ILLEGAL EVICTION FROM THE SAME, A POTENTIAL LEGAL MALPRACTICE CASE AGAINST MY LATE WIFE'S ESTATE, THE EXPENSE AND TIME TO FILE AN APPEAL OF THE HIGHLY QUESTIONABLE 3 JUNE 2022 BENCH WARRANT ORDER, ETC. THE LONGER I AM INCARCERATED ON THESE BENCH

WARRANTS THE MORE LIKELY AND GREATER THE POTENTIAL DAMAGES BECOME. I ALSO HAVE TO COMPLETE 60 HOURS OF CONTINUING EDUCATION WITHIN THE NEXT THREE WEEKS TO MAINTAIN MY PMP LICENSE.

WHILE ON THE SUBJECT OF APPEALING THE 3 JULY 2022 BENCH WARRANT ORDER, THE APPEAL NUMBER IS 2022-000940. I DO NOT KNOW IF SOMETHING LIKE SCRPC RULE 60 APPLIES TO A BENCH WARRANT ORDER. BUT IF SO, PLEASE REQUEST PERMISSION FROM THE SC COURT OF APPEALS AS SOON AS POSSIBLE SO THAT YOU OR WHOMEVER YOU APPOINT CAN TAKE THE NECESSARY ACTION TO RELEASE ME NO LATER THAN THIS COMING THURSDAY AFTERNOON, 27 JULY 2022.

LASTLY, I WOULD VERY MUCH APPRECIATE IT IF YOU COULD:

- ① DIRECT MS. WILSON'S OFFICE TO COMPLY WITH CHIEF JUDGE BEATTY'S OCTOBER 2018 ORDER REGARDING THE OPERATION OF THE CHARLESTON COUNTY GENERAL SESSIONS COURT.
- ② ENSURE I AM PROVIDED A COPY OF YOUR 30 MAR 2022 ORDER OF CONTINUANCE OF THE HEARING OF 31 MAR 2022 IN CASES 2021-A10-00102475 AND 2021-GS-10-07599

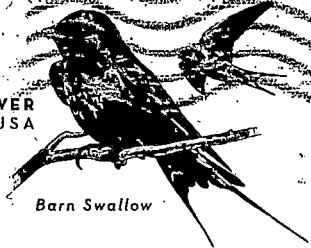
