Dear Ms. Allen:

In response to your letter dated July 26, 2022, requesting a status update on delivery of the transcripts of record in the above-referenced case, we have not yet received the transcripts. Two (2) transcripts of record for hearings held in the Court of Common Pleas on April 25, 2017, and August 30, 2021, respectively, were ordered on March 28, 2022. Ms. Krystal J. Smith is the Court Reporter assigned to produce the transcripts. After expiration of the initial sixty-day period for delivery of the transcripts provided by SCACR Rule 207(2), she requested and was granted two thirty-day extensions for both transcripts; first to June 28, 2022, and subsequently to July 28, 2022, in each case.
