Alice Swope Thompson appeals the following:


1. Order of the Honorable Clifton B. Newman dated February 2, 2022; and



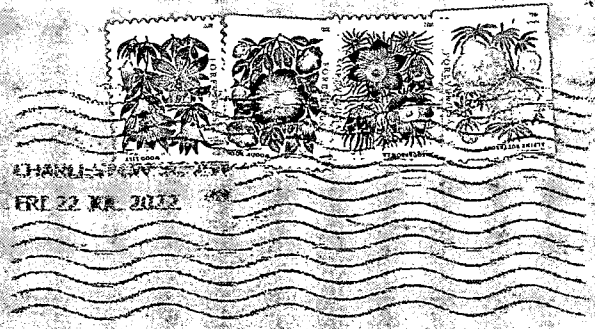
