I'll do my best to write OK, due to a man at Lex Jail pushed me down, hit my L side of head + hurt my L knee while in chains.

I am not guilty of what they say, also I taught S.S. in Oklawaha FL, w/ Southern Baptist mission, 2 ladies 1961-62. I have the teacher book of 1967 where they returned, 25 yrs there only 1 church they left there was 4.

I left north Greenville S.C. Nov 30, 62 to join US Army due to draft + 2 recruits came + talked to us men there, "would be best for us to go now + get it done I knew of 3 of us at Fort Jackson in same company.

I had many times had an angel to protect me. so many people would not even believe.

came home to S.C 11, 30, 62, went to L.A to work  
in Bethlehem steel mill to make money  
came home went to Steven Green mem Baptist  
1972-1990 Oct.

had a large ss class of 43, 39 Believed in  
Jesus Christ, was bus chair, 2 vans,  
Brother hood speaker, C. B. Agius to help my  
wife Susan Green mother of Ana Chambers  
praise church 2, 4, 5th Sunday at 5am.

In late 1990 Susan told me we need to move  
to Lex county, her girl from date rape  
was w/ child, he came 4/8/91 we went to  
Judge Westbrook to do adop' Joseph, he was  
A smart, pretty baby, Grad VVT Cert West  
COA. A BSA, engine scout, on mission trips  
to AZ 2006, 7, 8 and w/us to N.C. Mt's park  
Also helped w/ 3 people Bodie, West Co, James King  
Wagner, Lady Kennedy w/ 3 little boys of mix  
we fed Bodie & yard, King fed him & cut wood  
for BSA camps, he just helped Kennedy feed  
& on BBS & all S.A.T.A.C.

Note how said King my age 1941 died 2015 1 yr  
after I was locked up Bodie. Bone marrow cancer?  
Mrs Kennedy passed 2015 mth.

I have a very good job in L.A. Calif. w/ steel company Bethlehem in early mid 60's. save my money to build my home in Winnsboro, Ga & serve my church, do noon talks to old people, Brother hood, Jail County Fairfield 72-90 2, 4, 5<sup>th</sup> Sun at 8 AM S.S. Al 10, 11 smoke, bus chair, <sup>VANS</sup> 2 vans, BSA w/ Joseph in West Coast Troop 331, helped Shepherd Henmon Young get Troop 49 in Winnsboro, Ga get started up again. my troop in 50's ascess.

my hand is shaking have to stop for later from Cox SA 2 guard pushed me down in Transport truck 2018, hit my L-side of head on metal floor of truck,

In Lex C. Jail the men, nurses of faith looked after me after the bad things done to me per West C. P.A., bad food 1 ~~cell~~, bad food, they got meds & items to me to help gain wt. Back up from 168, norm 185, moved to floor 3 times, hot old jail, Rorch Inked Room Bottom Floor, noise & yelling definite.

A certain guard cut's title took skin off arm & wrist made clean up donkey rooms when others left that way, put me with all meth people for yrs till 2 christian guards went to someone told them I made no trouble or said not one word.

When my days (4) in court so to SCDC B+E 118 days, food taken 13 times till a guard from area knew of me, walked to mess hall & got us 2 food & got rid of ones taking food.

Here in Edom, med down we had 2 BIBLE CLASSES until bad bug hit, now 2 yrs later still no class!

There is so much more wrong with SC's JAMS & SCDC most due to people in charge all way to down town!

My Dad passed 12/25/53 at 5AM with me waking him to go to milk bank.

Susan fell due to inner ear mins before 12 noon hit head on chair bottom rolled on to her little paring knife, I saw only the picture where it hit her, heart only looked to be 1/2 inch would have missed!

Being whatever Native Am, she made me promise to have natural B. with or none A old site of N.A. people

to get my credit score up, we always used Susan's  
cc run up pay down to 1-2000.00 to keep her cc up  
I was 10-13,000, 700, 1300, 3-400 All in BB & T  
envelopes. Cash to take to Pickens to deposit &  
pay on house not far from N Greenville Baptist College  
for Joseph

when time came to move ~~items~~ all house  
all gone. I know long time sled men would steal  
& know any cop could also.

example: A sled man gave me a ride home  
weed was very strong in his car  
while in car weed was allowed - never saw a person give problem!

Retirement. due to my looks they 1/2 AM. 1/2 other

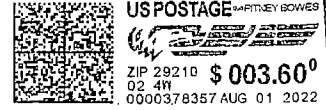
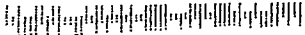
filled the class, my nick name WAS "5 AM"
