**JOINT MOTION TO STAY BRIEFING SCHEDULE**



**PLEASE TAKE NOTICE THAT** Appellant, Charleston Advancement Academy High School, and Respondent, South Carolina Public Charter School District, hereby Jointly move this Court for an Order staying the deadlines in the briefing schedule and is made on the grounds that they have voluntarily agreed to mediate their dispute arising out




