This affidavit of appeal serves as official notice of my intent to appeal a notice of "writ of assistance" filed on July 25th 2022 in reference to the property located at 26 Heritage Hills Columbia SC 29203. The decision is being appealed as it directly violates my valid claim to this property. The property located at 26 Heritage Hills was obtained on March 1, 2021 from Boss Bag Investments llc as a rent to own property, on the day of March 1, 2021 the appropriate documents such as the rent to own agreement was signed and dated and a deposit of \$5000 was made, as a result i was granted access (by way of keys) to the property. At that point utilities were then activated at the address , in addition a countless amount of repairs and maintenance cost had been invested into the property including but not limited to plumbing, lawn maintenance, painting, and carpet maintenance .This property has been maintained openly and outwardly at all times , even fostering friendships and business relationships with neighbors (Donna Alvarez 28 Heritage hills Columbia SC 29203) to help upkeep the property in the event of my absence (business travel etc.). So it is with pure befuddlement to learn of the claimant "Pressley Properties" claims of ownership to the property. The claimant (pressley properties) on July 8 2022 came to the property and introduced himself as a "representative for the individual who purchased the home", I explained to the claimant how that was impossible being that I was currently renting the home, he then left but continued to make random appearances on the property, specifically around the Mailbox. On July 25th 2022 I received a notice of "writ of assistance" stating that I had approximately thirty days to vacate the premises, much to my astonishment as I had never received any sought of court documentation summoning me to appear in any hearings to exercise my right to present my proof for claim of ownership. I am requesting that the court of appeals dismiss the judgment made on July 25th 2022 for " writ of assistance" and set forth a hearing for continuation on case # 2020-cp-40-5279 for a future date where sufficient evidence to my claim can be reviewed
