

Appellant received (5) five years suspended on (30) thirty months and (30) thirty months probation on all but the Shoplifting. Appellant received (1) one year on the shoplifting. 

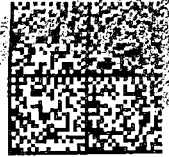
