Page 12, Line 20:

*I think It should read:* You are guilty of trying to cover up Pet Helpers' "**fraud**".

Page 15, Line 2:

She filed her affidavit and a lengthy memo "of posing" our motion for Partial Summary Judgement.

*I think It should read:* She filed her affidavit and a lengthy memo "**opposing**" our motion for Partial Summary Judgement.

Page 17, Lines 8-10:

We're asking the court also, as part of that permanent injunction, to prohibit her from contacting the plaintiff, its staff, coming on to "her" property.

*I think It should read:* ...coming on to "**their**" property.

Page 18, Line 6-7

And they're giving you an adoption "redacted" form.

*I think It should read:* And they're giving you an adoption "**unredacted**" form.

Page 19, Line 21-23

And there's a lot of things in this case that Mr.Futeral has completely ignored, and I want to mention to him "and to" my law analysis...

*I think it should read:* to him "**from**" my law analysis...

Page 19, Line 25; Page 20, Line 2

But the "movement" may not present only the portion of the record supporting its position while knowingly "admitting"...

*I think it should read:* But the "movant" may not present only the portions of the record supporting its position while knowingly "omitting" evidence to the contrary that may raise an issue of material fact.

Page 20, Lines 24-25; Page 21, Lines 1

And then I found out about the euthanasia that Ms. Susko is authorized—certified to do. And so I assumed because I—that they had killed him. I did not say it. I just, that was my belief after I saw how they treated they would—they just let him suffer and they did.

*I think it should read:* And then I found out about the euthanasia that Ms. Susko is authorized—certified to do. And so I assumed because I "**heard that**" they had killed him. I did not say it, I just, that was my belief after I saw how they would—they just let him suffer and they did.

(I am not sure I said, "I did not say it".)

Page 22, line 9

They've lied to me by implying that I could get the dog back, which "when" I submitted an application

*I believe it should read:* They've lied to me implying that I could get the dog back, which "**then**" I submitted an application.

Page 22, Line 22

Ms. Lindell

I believe it should read: **Ms. Linville**

**Page 23, Lines 2- 6**

I'm also saying that if there's any ---- in many courts, judges have decided that if there is the least bit of doubt that there's a material issue of fact that the judge should not grant summary judgement or partial summary judgement.

*I believe it should read:* I'm also saying that if there's any "doubt" in many courts, judges have decided that if there's the least bit of doubt that there's a material issue of fact that the judge should not grant summary judgement or partial summary judgement.

Page 24, Line 2

I did file a "leak"...

I believe it should read: I did file "**a Leave to Supplement my answer**".

Page 25, Line 20-21

I just figured, oh okay, they kept him, they made money on him, and they killed "her".

I believe it should read: I just figured, oh, okay, they kept him, they made money on him, and they killed "him".
