**PETITIONER DUKE ENERGY CAROLINAS, LLC'S MOTION FOR EXTENSION
OF TIME TO FILE PETITION FOR CERTIORARI**

Petitioner Duke Energy Carolinas, LLC ("Duke") moves, pursuant to Rule 240, SCACR, for an extension of time to file a petition for certiorari of Opinion No. 5062, filed by the Court of Appeals on May 1, 2013 ("Opinion"). Pursuant to Rule 243, SCACR, a petition for certiorari for the Opinion is due on May 31, 2013. Duke requests a 28-day extension of time to June 28, 2013, to file its Petition for Writ of Certiorari and Appendix to Petition for Writ of Certiorari for the Opinion. The grounds for this Motion are that additional time is needed to fully prepare the Petition and to fully develop the grounds for requesting certiorari. Counsel's schedule has also

been occupied with various matters that preclude adequate preparation of the Petition by the May 31st date.

Counsel for Duke has consulted with counsel for Respondent South Carolina Department of Health and Environmental Control and counsel for Respondents' American Rivers and The South Carolina Coastal Conservation League, both of whom have advised counsel for Duke that they take no position on this Motion.

WHEREFORE, Duke respectfully requests a 28-day extension of time to June 28, 2013, to file its Petition for Writ of Certiorari and Appendix to Petition for Writ of Certiorari for the Opinion.




