INVOLVED IN APPEAL 2022-00940 WILL BE RESPONSIBLE.

THE TRANSCRIPT HAS ALREADY BEEN ORDERED BUT I OBVIOUSLY DO NOT HAVE IT AT THE CHARLESTON COUNTY DETENTION CENTER.

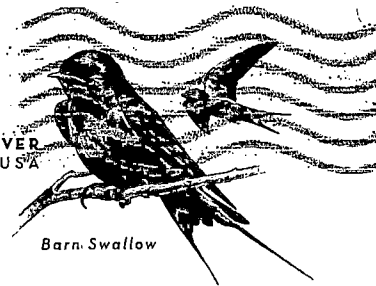
