RESENTENCING HEARING.

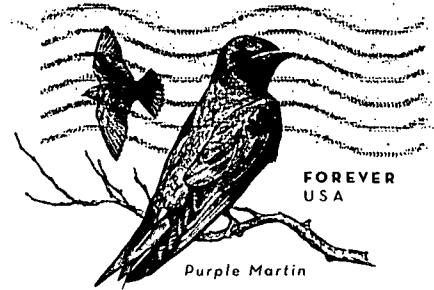

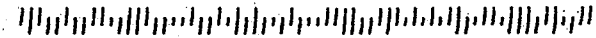

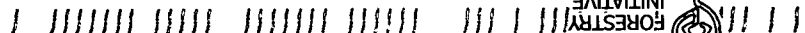
