ORDER



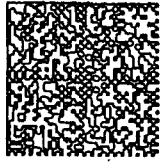
