Statement of Interest

Equity, disregards form, ignores fictions and subordinated technicalities

In the matter of Collins, Samuel Tucker Jr., Care of 2398 Hotel Street, Alcolu, South Carolina [29001] versus Frank Jones of 15 West Rigby Street Manning, South Carolina 29102

I, Collins, Samuel Tucker Jr. having knowledge of the herein stated facts and being competent to witness, depose and say: I, Collins, Samuel Tucker Jr. a man with the Soles of his feet from/on the land bestowed by nature and nature's God with manifested interest, hereby declare that I am a Private Inhabitant in the United States and a friend thereof, and I am not an enemy belligerent under the Trading with The Enemy's Act of 1933.

I am invoking my Equitable Rights in Exclusive Equity as a Private Holder/Grantee in the United States. I move the Court to Annihilate the public rules of the at law court since they do not apply here given the private claim.

Because of the private nature, I request that this case be sealed. If the Court does not agree that this matter is private, then show cause why this case should not be sealed. I take Judicial Notice of the Honorable Chancellor's Oath of Office and Surety Bond. You are a private trustee. I am the Private Grantee of the SAMUEL TUCKER COLLINS resulting trust you are administering here in this matter and I am requesting the court to show cause why they have superior jurisdiction to administrate this matter in a public court venue.

Collins, Samuel Tucker Jr. is the Private Name Holder of the res (property) and deeds which represent it, and I am cestui que of the resultant trust SAMUEL TUCKER COLLINS. Qui prior est tempore potior est jure- "He who is prior in time is superior in right" Gibson's Treatise on suits in chancery §55; This statement of fact is proven by the attached "Minnesota Business Name Certificate Number 1327688600022", including its Certificate of Existence, Certification of active status in Good Standing and finally the Certification of record.

As Name Holder bona fide, the cestui que comes now, present in full life and with clean hands. I have absolute unfettered equitable title to the res, aka beneficial title holder, aka beneficial holder, aka sole beneficiary, who has been trespassed against by dolus parties by way of dolus malus. "Equity Regards the Beneficiary as the Real Owner" Gibson's Treatise on suits in chancery §64. These proceedings have/are irreparably harming the holder of right, title and interest not cognizable by a court of law.

I know who the beneficiary of the private trust is, and it is not anyone in this court nor any other party(s). This action is presently under a special and private trust arrangement governed by the Maxims of Equity, whereby the Judicature Act of 1873 is in operation, "when the rules of common law and the rules of equity conflict over the same subject matter the rules of equity shall prevail" (Pomeroy, Eq. Jur. §124, §219, §279, §354, §357) Equity is about Status and Jurisdiction. Equity compels that, if this Honorable Court does not have Authority over Private Trusts, and, if said Court cannot show cause why the Jurisdiction and Orders of this court and the lower courts, (County Magistrate and Court of Common Pleas) these lower Courts rulings must be reversed and all other Commercial hearings cancelled.

For this Bill in Equity, number: **2022-000865**, I am requesting a full non-comingled accounting of the equitable and legal side of the ledger and recoupment of all res in the name of SAMUEL TUCKER COLLINS JR. "Gilbert Law Summaries Trust" pg.159. "Where a sole trustee and sole beneficiary is one and the same person, the result is a merger of legal and equitable titles, defeating the trust and creating a fee simple in the holder; interest must be exactly the same for merger to occur. Rights are said to be merged when the same person who is bound to pay is also entitled to receive. This is more properly called a confusion of rights, or extinguishment when notice of an equitable claim over the same subject matter is not rebutted by proper notice. (Gibson Waiver/Consent/Priority).

1. **Collins, Samuel Tucker Jr.**, private name holder, has vested financial and equitable interest in the property commonly described as **2398 Hotel Street, Alcolu, South Carolina [29001]**.
2. **Collins, Samuel Tucker Jr.'s** vested equitable interest in the location described as: **2398 Hotel Street Alcolu, South Carolina [29001]**; carrying an equitable right of present and future enjoyment and is the possessor of the property.
3. The value of the res held by **Collins, Samuel Tucker Jr.** is **Eighty Thousand Dollars, (\$80,000)**

In light of the violations of my equitable rights as holder of the res, this is my **Statement of Interest** pertaining to the property listed as: **2398 Hotel Street Alcolu, South Carolina [29001]** and remedies for trespass as follows: Due to the dishonorable, clandestine and Colorable Actions/Non-Action(s) of **David Epperson d/b/a DAVID EPPERSON ESQUIRE, in the OFFICE OF CLARENDON COUNTY ADMINISTRATOR, BAR NUMBER 70434** "**Equity will Undo What Fraud Has Done**", Gibson's Treatise on suits in chancery §48; "**Equity will not permit a statute to be used as a cloak for fraud**", (actual, and constructive fraud), Gibson's Treatise on suits in chancery §51; "**No one Can Take Advantage of His Own Wrong**", Treatise on suits in chancery §52.

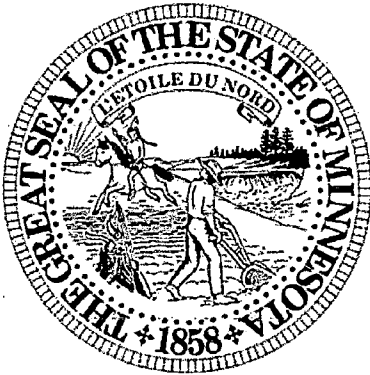

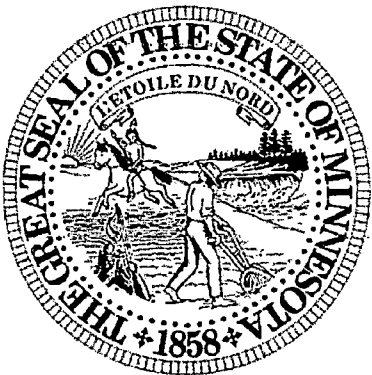

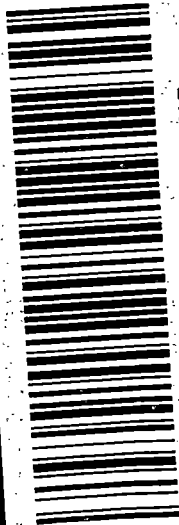
