The Court filed its Order on the merits in this case on October 20, 2021 which, in its caption, was designated "Final Order". However, the Order was not final, inasmuch as by its own terms the Imperial Docks is required to file its attorney fee affidavit within fourteen (14) days of the filing of the Order, to which the Siscos must file their response seven (7) days thereafter.

The parties have requested the Court to clarify the status of the Order filed October 20<sup>th</sup>, for the purposes of timing the filing of any reconsideration motions or an appeal. The Court finds that it is reasonable and proper to re-characterize the October 20<sup>th</sup> Order, as simply an “Order” and to provide that the final order in the case will be filed after the Court has ruled upon the attorney fee issues.

Now, therefore, on motion of Capers G. Barr, III, attorney for Richard and Deborah Sisco, and with the consent of William P. Tinkler, attorney for Imperial Docks by Design, LLC, it is

ORDERED that the Order heretofore filed October 20, 2021 in this case shall be designated as “Order”, and not a “Final Order”; and it is further

ORDERED that the “Final Order” in this case shall be issued at such time as the Court rules upon the pending attorney fee issue.
