**MOTION FOR EXTENSION TO  
FILE EXHIBITS UNDER SEAL**



The Attorney General, Appellant/Respondent in this appeal, hereby moves for a seven day extension of time, to and through May 24, 2013, in which to file the designated exhibits under seal, as permitted by the Order of this Court filed May 2, 2013. The cover letter accompanying that Order, also dated May 2, 2013, stated that the exhibits should be filed within 15 days of the date of that letter, *i.e.*, by May 17, 2013.

The primary reason for this request is that in the hope of being of assistance to the Court, the Attorney General's Office is in the process of noting those exhibits that were provided by the State Grand Jury to Respondent/Appellant Field as part of criminal discovery that took place after the initial briefs in this case were filed. That process has proven to be very time-consuming, because it involves comparing the list of documents produced to Field by the State Grand Jury to the list of documents designated in the present case by Appellant/Respondent. In addition, the Court's letter and Order of May 2, 2013, were not actually received by counsel for the Attorney General until May 6, 2013, which had the effect of shortening the available time.

For the foregoing reasons, the Attorney General's Office therefore respectfully requests an additional seven days, through May 24, 2013, in which to file the exhibits under seal.
