**RESPONDENTS' JOINT RETURN TO APPELLANT'S MOTION FOR
REINSTATEMENT**

Pursuant to South Carolina Appellate Court Rule 240, Respondents, Stephen Dudek, Doreen Cross, Michael Scarafile, Susan Nicholson, Carolina One Real Estate, Carrie Boyer, Woody Law Firm, Allison Williams and First Federal¹ (herein collectively the "Respondents"), jointly file this Return in opposition to Appellant's Motion for Reinstatement, pursuant to Rule 260, SCACR. Respondents oppose the relief sought in Appellant's Motion and disagree with the assertions made therein. Appellant was ordered by this court to serve and file a compliant record on appeal on February 23, 2021, May 27, 2021, and again on August 16, 2021. On January 14,

2022, this court directed Appellant to serve a fully redacted amended record on appeal within ten days. Appellant failed to comply. Therefore, on May 24, 2022, this court dismissed Appellant's appeal.

Appellant has refused to comply with the South Carolina Appellate Court Rules and has continued to violate this Court's orders. Respondents' Motion to Dismiss was properly granted and Appellant's Motion for Reinstatement should be denied.
