MOTION FOR AN EXTENSION OF TIME TO

1. The initial brief of appellant and designation of matter in this case are due to be served and filed with the Court today.

Counsel filed the Johnson petition for writ of certiorari and accompanying appendix in the case of Jason Cash v. State in the Supreme Court on July 18, 2022. Counsel filed the brief of petitioner in the case of State v. Nathaniel Bradley in this Court on July 13, 2022.

4. Counsel makes this request in good faith and not for purpose of delay.






