**MOTION FOR EXTENSION TO FILE
THE AMENDED INITIAL BRIEF OF APPELLANT**

The Movant would respectfully show unto the Court as follows in support of the Motion for an Extension to File the Amended Initial Brief of Appellant pursuant to the Order of the Court of September 12, 2022:

1. That the Appellant filed the Initial Brief and Designation of Matter on June 28, 2022 and on July 1, 2022 filed a Motion to Exceed the Page Limit. By Order of the Court on September 12, 2022, the Court denied the Motion to Exceed the Page Limit and allowed the Appellant twenty (20) days to file and serve an Amended Initial Brief not exceeding the fifty (50) page limit.

2. That lead Counsel for the Appellant has filed letters of protection with every Court and with the SC Workers' Compensation Commission before whom he appears for protection for a vacation from September 23rd through October 11, 2022. On September 12th via email the Order of the Court was received late in the afternoon at 4:03 o'clock pm, thus effectively being received on September 13th, and allowing Counsel twenty (20) days in which to completely revise and reassemble the Initial Brief of Appellant.

3. That pursuant to the Order of the Court the Amended Initial Brief of Appellant is due to be filed and served on October 2nd. In accordance with the normal policy of the Court of granting a thirty (30) day extension from the last date that a matter is due to be filed with the Court, a thirty (30) day extension from the date of October 2nd would effectively give Counsel upon return from vacation 19-20 days to file the Amended Brief.

4. That as the Court is aware, lead Counsel for the Appellant has an active trial practice and taking the time away from his other clients to review and revise and completely restructure the Initial Brief at a time that Counsel is doing all types of work on the files of his other clients in preparation of being out of the office would do a disservice to his other clients and their causes. Counsel would ask the Court

to take notice of the fact in reference to any time away from a trial practice, that either action on files has to be accelerated and taken care of prior to the time of being out of the office or put off or postponed until after returning to the office. Thus, there is a tremendous amount of workload both going into time off and coming back from time off.

Wherefore, Counsel for the Appellant would respectfully request an extension of thirty (30) days from the date of his return from vacation, making Appellant's Amended Initial Brief due on November 11, 2022; or would request an extension of at least thirty (30) days from the date that the Brief is due on October 2nd. Any consideration of an extension that the Court deems appropriate to give is greatly appreciated.



I am in receipt of the Order denying the Motion to Exceed Page Limits and please find attached a Motion for an Extension to file the Amended Initial Appellant's Brief in the above-referenced matter. Because of the special circumstances involved in making this request, I am sending a copy of this cover letter to Chief Judge Aphrodite Konduros and to Judge Garrison Hill who signed the Order denying the original Motion.

The Order requires Mr. Malloy and I to file our Initial Brief within twenty (20) days making the Brief due October 2, 2022. I have a two week vacation planned from September 23rd and returning to the office on October 11th. I obtained protection from every Court and Commission before whom I appear except for the Court of Appeals. 
