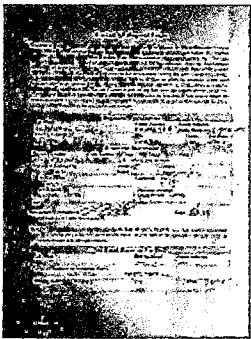

This is to confirm receipt of your email dated September 2, 2022, requesting production of a transcript in the above referenced matter that was held before The Honorable Judge Debra McCaslin, Lexington County, South Carolina, on August 29, 2022.

The transcript will be approximately fifteen (15) pages at \$4.25 per page for an estimated price of \$63.75.

Pursuant to Rule 607, the total estimated amount indicated above is due for the transcript you have requested. Upon receipt of the estimated amount due - certified check or money order (no personal checks) - your transcript request will be placed in line for production. Certified check or money order should be made payable to Betty R. Lyons and sent to 747 Bishops Circle, Evans, Georgia, 30809. Please include the case name and date for which this certified check or money order is to be applied, as I get multiple requests and monies on daily basis.

If I have underestimated the number of pages, you will be notified prior to delivery of the transcript of the balance due. If I have overestimated the number of pages, you will be refunded the overpayment. Under the South Carolina Rules, a court reporter has 60 days from the date of request to complete the transcript. In this instance, the 60-day period will be determined based on the date the total estimated amount due has been received. You will be notified if any extensions are approved by Court Administration beyond 60 days.
