MOTION FOR AN EXTENSION OF TIME TO

Counsel for Joey Corvell Reid respectfully requests a thirty (30) day extension from September 28, 2022 until October 28, 2022, in which to serve and file the Initial Brief of Respondent and Designation of Matter in this case. 

3. This request is made in good faith, and not for purposes of delay. Counsel intends to continue to work on the cases with more than three extensions first so that the caseload will hopefully become more manageable in the near future, and less extensions will need to be requested.

4. Opposing counsel Matthew C. Buchanan, Esquire, has graciously consented to, or does not oppose this extension.

WHEREFORE, the undersigned counsel would respectfully request a thirty-day extension from September 28, 2022 until October 28, 2022. Counsel respectfully requests that the time limits for filing the Initial Brief of Respondent and Designation of Matter be held in abeyance pending a ruling on this motion.
