MOTION TO RELIEVE COUNSEL

On February 22, 2018, undersigned counsel was assigned to represent Appellant, Justin Martel Wilson, concerning his direct appeal. On August 23, 2018, counsel filed a motion to remand the case to the circuit court and reconstruct the record where bench conferences were not transcribed. 
