The motion fee of \$50.00 will be mailed with the hard copies today.

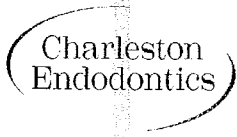

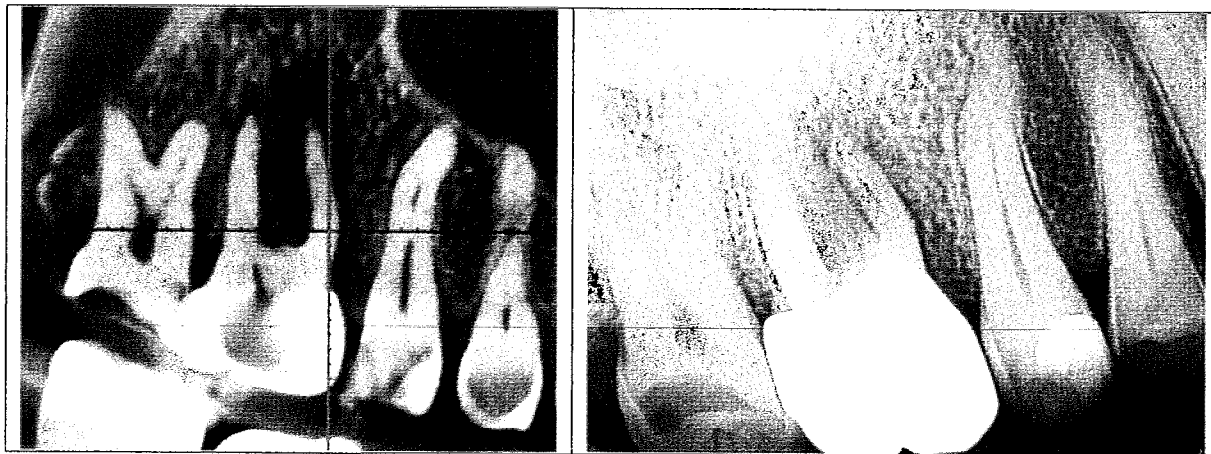
Dear Dr. Spevak,

Thank you for referring Janet for endodontic consultation. As you're aware, her chief complaint was extreme sensitivity to cold in the back upper right and pain to biting in the same area. Thorough clinical and radiographic examination was completed in the upper right quadrant. Tooth #2 was diagnosed with reversible pulpitis / normal periapex due to bruxism stripping away the enamel. This tooth has dentin sensitivity and requires a direct restoration to alleviate the sensitivity. Tooth #3 was diagnosed with pulpal necrosis / chronic apical abscess. This tooth has class III mobility and severe attachment loss likely due to a fractured root or furcal floor fracture. This tooth will require extraction. I referred her to COAFS for the procedure. Janet would like to discuss options for #2 and replacing #3 after she has healed from the extraction. Please don't hesitate to contact me if you have any questions. Thank you for the great referrals.

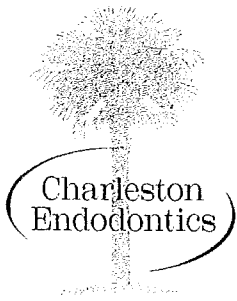
