

Destruction and damage of My Personal Property

To whom this may concern, I Karen Polite can not express what I'm feeling right now I am devastated, and broken. 💔 What kind of world are we living in? Is there no justice and or peace for people like me, living on property for more than 30 years? I have cried out for help so many times over the years, to the Authorities and the Courts. I've repeatedly asked Attorney Allison Eversole, the attorney for Rachel Polite Chaplain, to talk to her client about her adult children's harassment and bullying. Nothing and nothing had been done about this harassment and intimidation.

On last Friday September 9th 2022 I submitted photos of the destruction and damage of my home located at 6 Ladson road St. Helena. On September 5th 2022 Monday Labor Day, I reached out to this court and Attorney Allison Eversole about her client Rachel Polite Chaplain, invitation of guests and invitees on this property harassing and intimidating me, now (4) days later my home is on the ground sitting with major damage broken glass both inside and out, one of two television destroyed \$350,(2) broken house windows \$284, busted pipelines\$140,water damage from the rain inside my home, my front deck is completely destroyed \$2500, cabinets in my kitchen and floors value at \$8,000 not even 3 years old. My wall interior is \$280, my roof inside.The cost associated with lifting my home back up, on blocks is \$7,000.

My pet dog was trapped in a corner, where a dresser fell down just missing him. My home is without running water, and the structure is off balance. I have to live here under these conditions, because my dog and I have nowhere else to go. I'm afraid something else may happen when I'm not at home, like I said before. Thank God for the critical thinking of my dad, the late Bubby Polite, for putting my electricity underground.

I will not accuse God of this horrific, horrible and unnecessary act that took place. Because this only happens when I'm away from my home, including a human sized hole in my roof that happened on August 22, 2022 including the Tie-Down holding my home in place, costing more than \$10,000 in damage. The photos of the roof and scraps have been taken with a body cam by (Sergeant Mankin) of Beaufort County Law Enforcement. Can someone please

tell me what am I doing wrong? And what do I need to do, to protect myself from Allison Eversole's client Rachel Polite Chaplain her guests and invitees. Also am I the defendant or the victim?

At this point I truly believe I Karen Polite I'm under attack as the victim of Miss Allison Eversole client Rachel Polite Chaplain, who repeatedly directs her guests and inventies on to this property. The Red Cross was able to assist me with funds, to get me through the weekend. I have not worked since last Friday, because of the emotional exhaustion state I'm not resting well in disbelief.

So Please be advised that I will not be able to pay your client any money for now because of this horrific, horrible incident that took place on this property. I do not have insurance on my home, and your client hired people to cut down trees, remove trees and much more. Rachel Polite Chaplin should be responsible for whatever damage took place on before or after my home fell to the ground.

Attorney Allison Eversole, your client has brought her guests and invitees onto this property more than once, even before the trial back in November 2020. In 2022 after reporting this incident on September 5, 2022, four days later my home was on the ground on September 9, 2022. I'm appealing to this court of law to help me understand this ongoing case of harassment, stalking, intimidation and now bullying why; by the client of Allison Eversole keeps happening. Rachel Polite also admitted to Beaufort County Sheriff offices, about her invitation of her guests and invitees onto this property.

I have made several reports over the years, and three reports within a month August 15, 22, of 2022 and September 5, 2022 leading up to friday September 9, 2022. This has been my home since 1988 for more than 30 years standing Approximately 4 and 1/2 feet high, and now on the ground with lots of destruction and damage to my personal property.
