

DOMESTIC VIOLENCE OF A HIGH AND AGGRAVATED NATURE

The defendant, William Matthew Sloan II, on or about April 14, 2022 in York County, South Carolina, did cause physical harm or injury to [REDACTED] a household member, or did offer or attempt to cause physical harm or injury to said household member with apparent present ability under circumstances reasonably creating fear of imminent peril. In addition, the offense was committed, with or without an accompanying battery, under circumstances manifesting extreme indifference to the value of human life, which would reasonably cause a person to fear imminent great bodily injury or death. All in violation of 16-25-0065(A), *Code of Laws of South Carolina* (1976, as amended).
