This matter came before the Court upon the dual Petition of Tomeka L. Robinson Thiam seeking to be named Conservator and Guardian for her mother, Sandra Y. Robinson. A hearing was held at 11:00 AM on August 24, 2022 at the Darlington County Probate Court. Present at the hearing were Tomeka L. Robinson Thiam and her counsel, Benson Driggers Esq, and Gerald Malloy Esq. Also present was Respondent Gadine Robinson and his Counsel, Johnny Watson, Esq. Deon Robinson was also present but not represented by counsel.

In reviewing the record and in light of testimony presented at the hearing, the evidence establishes that Ms. Sandra Y. Robinson is in need of a Conservator and Guardian to manage her affairs. An Examiner's Report and Affidavit signed by Dr. Joseph Healy was filed as part of Tomeka L. Robinson Thiam's Petition. In that report Dr. Healey notes that Sandra Y. Robinson has been diagnosed with progressive and permanent dementia and needs total assistance with daily living and decision making. It is Dr. Healy's opinion that Sandra Y. Robinson needs a guardian and conservator named for her.
