
NOTICE IS HEREBY GIVEN, that the Appellant, **JABYRON TYWOINE RICHARDSON**, through his undersigned attorney, within ten (10) days of the date hereof, or as soon thereafter as Counsel may be heard, move before the South Carolina Court of Appeals for a second extension of time to order the trial transcript based on the following grounds:

1. Appellant was tried and convicted of PWID/Dist. of Cocaine/LSD/other Narcotic drugs in Sch. 1(b) & (c)/Sched. II, 3rd offense; Drugs/Trafficking in cocaine, 10g or more, but less than 28g – 3rd or sub. offense; Drugs/Manuf., poss of other sub. in Sch. I, II, III or flunitrazepam, w.i.t.d. – 3rd or sub. offense; and Drugs/Trafficking in meth or cocaine base – 10 g or more, but less than 28g – 3rd or sub. offense.
2. The undersigned Representative of the Appellant is the trial Counsel.

3. Appellant is in the process of completing his Affidavit of Indigent Defense. Further, the Appellant has special medical needs which include a tracheostomy and the need for dialysis and medical appointments, which have contributed to the need for this second request for extension. Once the Affidavit is completed, it will be forwarded to the South Carolina Commission on Indigent Defense.
4. Counsel, therefore, requests an extension of time to order the trial transcript.


