

Assault / Assault & Battery in the 2<sup>nd</sup> degree;  
Possession of Cocaine

At a Court of General Sessions, convened on January 26, 2012 the Grand Jurors of WILLIAMSBURG County present upon their oath:

COUNT ONE – ASSAULT AND BATTERY IN THE 2<sup>ND</sup> DEGREE

That **David Jeffrey Major** and **Kyra L. Alston** did in **Williamsburg** on or about **August 19, 2011**, violate Section 16-3-600(D)(1) of the Code of Laws of South Carolina (1976), as amended, in that he did unlawfully injure another person, that person being **Mr. Nick McFadden**, or offer or attempt to injure another person with the present ability to do so and moderate bodily injury to another person resulted or moderate bodily injury to another person could have resulted.

COUNT TWO – POSSESSION OF COCAINE, 1<sup>ST</sup> OFFENSE

That **David Jeffrey Major** did in **Williamsburg County** on or about **August 19, 2011**, knowingly and intentionally possess a quantity of **Cocaine**, a controlled substance under the provisions of Act No. 445, Acts of the 1971 General Assembly of South Carolina, as amended (Section 44-53-370 et. seq., 1976 Code of Laws of South Carolina, as amended), such possession not having been authorized by law.

Against the peace and dignity of the State, and contrary to the statute in such case made and provided.

**COUNT ONE - BURGLARY, THIRD DEGREE**

That David J. Major did in Williamsburg County on or about February 9, 2013, enter without consent and with intent to commit a crime therein a building of Deloris Green located at 969 Ditchbank Road, in violation of Section 16-11-0313, S. C. Code of Laws, 1976, as amended.
