**APPELLANT’S MOTION FOR AN EXTENSION OF THE  
DEADLINE BY WHICH IT MAY FILE  
A PETITION FOR REHEARING**

By an unpublished decision filed October 12, 2022, the Court affirmed the entirety of the decision issued by the South Carolina Administrative Law Court in the instant matter.

By operation of South Carolina Appellate Court Rule 221(a), SCDC now confronts a deadline of Thursday, October 27, 2022 by which to file a petition for rehearing regarding the Court’s October 12, 2022 unpublished decision.

For the reasons stated below, SCDC, by and through its undersigned counsel, respectfully moves the Court for an extension of the deadline by which it may file a petition for rehearing in the instant matter.

Specifically, SCDC’s undersigned counsel now respectfully moves this Court for an extension of the deadline by which SCDC must file and serve a petition for rehearing from Thursday, October 27, 2022 to Monday, November 14, 2022.
