**JOINT MOTION FOR EXTENSION OF TIME TO FILE A PETITION FOR WRIT OF
CERTIORARI**

Pursuant to Rules 240 and 263(b), SCACR, the parties jointly move the South Carolina Supreme Court for an extension of time for filing a petition for writ of certiorari.

Under Rule 242, a party has 30 days after the South Carolina Court of Appeals decides a petition for rehearing to file a petition for writ of certiorari. Here, the Court of Appeals denied Respondents' petition for rehearing *en banc* on September 27, 2022. Therefore, the current deadline for filing a petition for writ of certiorari is October 28, 2022.

Rule 263(b) authorizes the appellate court or any justice thereof to extend the time for filing a petition for writ of certiorari. The parties are mediating this case on November 10, 2022. Accordingly, the parties jointly request the Supreme Court or any justice thereof extend the deadline for filing a petition for certiorari by 15 days to November 12, 2022, so that a petition for writ of certiorari may be filed if mediation is not successful.

A copy of this motion is being simultaneously filed with the Court of Appeals to prevent remittitur.
