
At a Court of General Sessions, convened on April 5, 2018 the Grand Jurors of SUMTER County present upon their oath:

COUNT ONE - TRAFFICKING IN MARIJUANA

That **William Lee Roseboro Jr.** did in **Sumter County** on or about **January 12, 2018**, knowingly, sell, manufacture, cultivate, deliver, purchase or bring into this state, or aid, abet, attempt or conspire to sell, manufacture, cultivate, deliver, purchase or bring into this state, or was knowingly in actual or constructive possession, or knowingly attempted to become in actual and/or constructive possession of a quantity of **Marijuana** in the amount of **one hundred pounds or more but less than two thousand pounds**, Marijuana being a controlled substance under §44-53-110, et. seq., South Carolina Code of Laws (1976, as amended), and in violation of §44-53-0370(e)(1)(b), South Carolina Code of Laws (1976, as amended).

Against the peace and dignity of the State, and contrary to the statute in such case made and provided.
