NOW COMES Petitioner, THI of South Carolina at Columbia, LLC, d/b/a Midlands Health & Rehabilitation Center, by and through its undersigned counsel, on the grounds stated below, pursuant to Rule 263(b), SCACR, as well as the Court's order of July 16, 2014, regarding Extensions in Cases Seeking a Petition for a Writ of Certiorari to Review a Decision of the South Carolina Court of Appeals, and hereby moves for an additional extension of ten (10) days' time to file/serve its petition to this Court for issuance of a writ of certiorari to the Court of Appeals to review its decision in this matter.

Presently, by order of this Court filed October 25, 2022, the deadline to file/serve a petition to this Court for a writ of certiorari today, November 3, 2022.
